


VIOLENCE PREVENTION FRAMEWORK: MODEL

The focus of this framework is to outline Cornerstone’s approach and implementation of prevention in the work that we do at all stages of engagement with clients and the community. It is Cornerstone’s goal to take action to prevent problems before they occur by implementing a primary prevention approach to address family violence.

Primary Prevention should not be seen in isolation from a broader spectrum of responses to family violence. It is important to recognize the interplay between responses and the need for responses to occur at all levels. These responses can be reinforced and build on each other helping to create safer families and communities.

VISION

Cornerstone is committed to addressing family violence by providing a comprehensive continuum of services to respond to its impacts. We will continue to invest in strengthening these services, so together we are a community committed to healthy, respectful relationships free from family violence or abuse.
